# **GENERAL TERMS AND CONDITIONS**

JEP – Power Electronics Day Hauts-de-France Organized by FM Promotion under the patronage of ACSIEL Alliance Electronique and Pôle MEDEE

### A. OBJECTIVE OF THE JEP – POWER ELECTRONICS DAY HAUTS-DE-FRANCE

Every year, the Power Electronics Day brings together the major players in the electronics industry in the Hautsde-France region to focus on a specific theme. Participants include strategix decision-makers in the industry, managers, technical directors, engineers and design offices, project managers, buyers and specifiers, technicians and design engineers.

### B. CONTENT OF FM PROMOTION'S SERVICES

The price includes:

- exhibition space rental (booths are set up randomly beforehand by the organizer, with the exception of partners, who are set up manually);
- exhibition equipment rental, there is only one type of stand:

### **1 – EXHIBITOR'S OBLIGATIONS**

By signing the General Conditions of Service, the exhibitor undertakes to:

- Distribute the invitation to its file of customers, contacts and prospects in the region.
- Respect the principles of equality of treatment and simplicity of presentation: equipment must be placed on the tables provided; posters may only be displayed within the confines of the stand; no sound presentation is permitted if it is likely to disturb other exhibitors.
- Respect the ban on alcoholic beverages on the exhibition site outside the cocktail reception.
- Do not organize presentations, seminars, conferences or other commercial activities in conjuction with or in the vicinity of JEP.
- Do not sublet all or part your pitch.
- Combly with any request or reminder from FM Promotion representatives.





#### **2 – PRICE AND PAYMENT**

In accordance with the rate defined in Section 3, an invoice payable on receipt will be sent by FM Promotion after validation of your participation.

### **3 – CANCELLATION**

Any cancellation bu the exhibitor must be notified in writing to FM Promotion – 59 rue des Petits Champs 75001 PARIS.

In the event of cancellation of a day's participation:

- 2 months before the date of the JEP, FM Promotion will reimburse the exhibitor 100%;
- Between 2 and 1 month before : 25% of the total amount is retained for administrative costs;
- Less than 1 month before the event, no refunds willbe made.
